Section 4: First aid measures

4.1 First-aid measures

General advice: If symptoms persist, call a physician. Do not breathe dust/fume/gas/mist/vapors/spray. Do not get in eyes, on the skin, or on clothing.

6.3 Methods and material for containment and cleaning up

Methods for containment: Prevent further leakage or spillage if safe to do so. Cover powder spill with a plastic sheet or tarp to minimize spreading. Dike far ahead of liquid spill for later disposal.

Methods for cleaning up: Use personal protective equipment as required. Cover powder spill with a plastic sheet or tarp to minimize spreading and keep the powder dry. Take up mechanically, placing in appropriate containers for disposal. Avoid creating dust. Clean contaminated surfaces thoroughly. Soak up with inert absorbent material. Dam up. Pick up and transfer to properly labeled containers. Sweep up and shovel into suitable containers for disposal. After cleaning, flush away traces with water. Take precautionary measures against static discharges.

7.1 Precautions for safe handling

Advice on safe handling: Avoid contact with skin, eyes, or clothing. Use personal protective equipment as required. Wash contaminated clothing before reuse. Do not breathe dust/fume/gas/mist/vapors/spray. Do not eat, drink or smoke when using this product. Use with local exhaust ventilation.

Storage conditions: Keep the container tightly closed in a dry and well-ventilated place. Keep out of the reach of children. Keep containers tightly closed in a cool, well-ventilated place. Keep in properly labeled containers. May form explosive peroxides.
